I am of legal age in the state of my residency. I agree that I am an independent contractor, responsible for determining my own business activities and not an agent or employee of the Company. I am responsible for the payment of all federal and state self-employment taxes and any other tax required under any federal, state or regulatory taxing agency. This position does not constitute the sale of a franchise or of a Membership and no fee, sales aids or services purchase or initial wholesale product purchase has been required of me for participation as a Representative. I agree that as a NUSSENTIALS Representative, I shall place primary emphasis upon the selling of Company products to non-Representative ultimate consumers. Members resident in the states of Maine, North Dakota, Michigan, Indiana, Iowa and West Virginia are limited to \$495.00 in purchases as a Representative from the Company during the first six months of Representative status. Permissible Representative purchases shall be automatically modified to comply with the exemption requirements set forth in any state's laws regulating business opportunities. In presenting NUSSENTIALS products I agree that such presentations shall be strictly according to the following format and that I will be terminated as a Representative if I fail to do so, a. In each presentation of the Representative position the prospect shall be directly informed that no fee or retail purchase is required to become NUSSENTIALS Representative. b. I agree that I shall sell the majority of my product sales (over 50%) to non-Representative consumers. Retail sales records shall be maintained and subject to review and verification upon Company request. c. In order to maintain a viable Marketing Program and to comply with changes to federal, state or local laws in economic conditions, NUSSENTIALS may provide additional Terms and Conditions for Representatives from time to time, as well as to modify its Representatives Compensation Program. Such Policies and Procedures and Compensation Plan modifications, and all changes thereto, shall become a binding part of this Agreement upon publication on the official NUSSENTIALS Web site or other official Company publication. d. I understand that no Attorney General or other regulatory authority ever registers or reviews, endorses or approves any product, compensation program or company, and I will make no such claim to others. e. I understand that my Representative position can be inherited or bequeathed, but cannot be transferred or assigned during my lifetime without written consent of the Company which consent will not be unreasonable withheld. f. This Agreement shall be in effect upon its receipt and acceptance by NUSSENTIALS CORP. g. I am responsible for supervising and supporting Representatives I sponsor into the program and in my commissionable down-line. I agree to maintain monthly communication and support to those

Representatives in my Commissionable down-line by the way of the following, or combination thereof: Personal contact, telephone communication, written communication, and attendance at Representative meetings. h. Payment terms on Representative purchases: credit card, money order or cashier check, with order. Commissions are payable to Representatives according to the Compensation Plan which is incorporated herein by reference. NUSSENTIALS may require an annual renewal fee. i. I will not make false or misleading or disparaging statements about NUSSENTIALS Representative positions or Company products. Display of commission checks, the making of income projections and use of Representative income testimonials to prospective Representatives is prohibited. I will conduct myself as a Representative in a courteous, fair and ethical manner. j. Representatives in the same household MAY have the same sponsor. Change of original sponsor is not permitted. Representative and customer lists and names are owned by Company and may never be used for any commercial or business purpose without prior written consent of Company. k. This Agreement is governed under the laws of the State of Texas. The parties agree that any claim, dispute or other difference between them shall be exclusively resolved by binding arbitration pursuant to the Commercial Rules of the American Arbitration Association with arbitration to occur at Houston, Texas. Louisiana Representatives arbitrate at New Orleans. I understand that the products purchased from NUSSENTIALS are manufactured and shipped from various locations worldwide and accept shipping delays beyond the control of NUSSENTIALS. NUSSENTIALS will make its best efforts to have all paid in full orders shipped within thirty (30) days from the date of order and payment. In order to maintain a viable marketing program NUSSENTIALS reserves the right to modify its compensation plan from time to time, and a thirty day (30), non-internet accessible literature, sales and wholesale products, are subject to return and 90% refund within 30 days of purchase. (1 year New Mexico and Montana, purchases within 1 year prior to termination of Representative status Wyoming, Georgia no time limitation, Massachusetts no time limitation as to Wholesale Purchases made for commission qualification.)
